Only 50% of the total rent paid applies to the future purchase of any non-rental instrument. 3. Refundable Deposit is returned when instrument is returned. 4. Rental term not to exceed 36 months.

I, the lessee, agree: 1. K.C. Strings must make all repairs to the above instrument but string replacement is not covered. 2. Payment is not refundable if instrument is returned early. 3. K.C. Strings requires a police report in case of theft or loss in fire. 4. I will notify K.C. Strings of any address, credit card or bank change. 5. To allow K.C. Strings and its representatives to pick-up the instrument from the school, home or elsewhere, with or without the knowledge of the renter if the rental payments are not kept current. 6. I fail to return the instrument, then I am responsible for all reasonable costs K.C. Strings incurs for the return of the instrument and/or agree to let K.C. Strings charge my credit card for rent due and/or the value of the instrument outfit minus the deposit and rent already paid to K.C. Strings. 7. My refundable deposit and credit toward instrument ownership is forfeited if my payments are not kept current. 8. This account can be forwarded to a collection agency, if the instrument is not returned and a balance is owed. 9. There is (a) no obligation to continue with the lease payments after the end of each rental period as set forth by this contract, (b) I can continue to use the instrument by making the next scheduled lease payment, (c) return the instrument to K.C. Strings, Inc., under previously specified conditions, in which case no further obligation will be incurred under the contract. 10. I have no right to sell, sublease, mortgage, pawn, pledge, encumber, or otherwise dispose of the instrument. 11. Title to the instrument outfit will not pass to me until the outfit price is paid in full.
